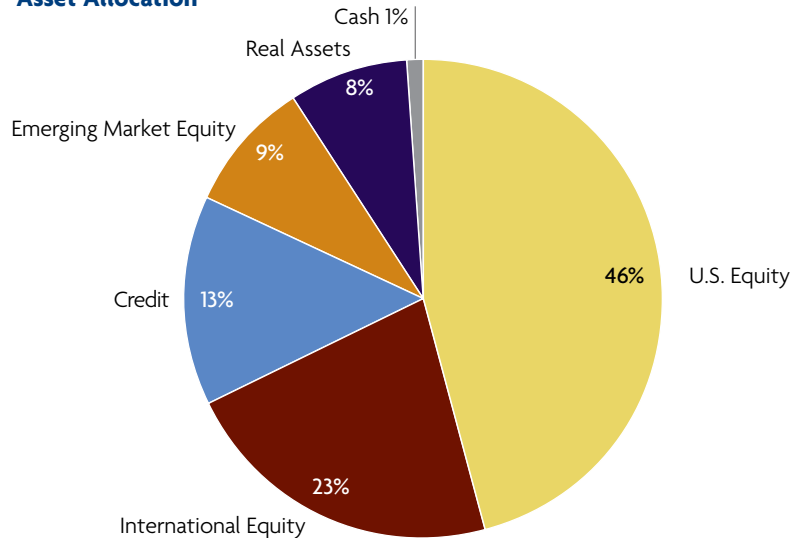
OBJECTIVE

The Growth objective seeks to provide investors with a higher degree of price appreciation by investing in a diversified portfolio focused on equity securities. While portfolios managed in this style may use a diverse set of investment strategies within fixed income and equity securities, this objective requires an investor with a high degree of risk tolerance as current income or safety of principal is not a priority for this objective. Investors in this objective should expect that by investing primarily in equity type securities, the potential for higher expected returns would be accompanied with a higher level of volatility (risk).

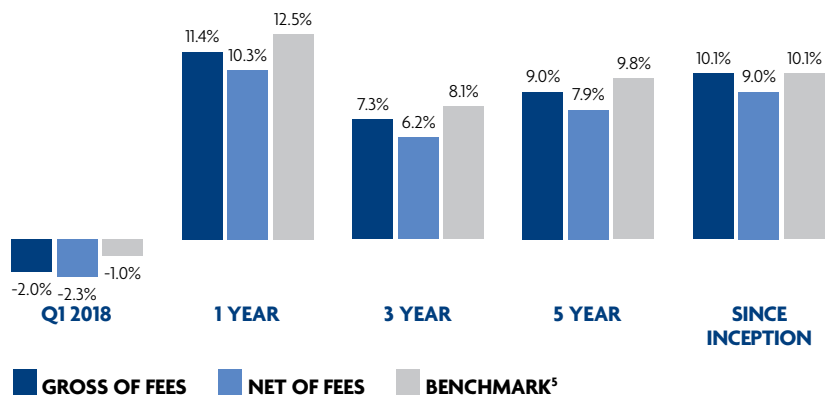

The Bloomberg Barclays U.S. Aggregate Bond Index is a broad-based benchmark that measures the investment grade, U.S. dollar-denominated, fixed-rate taxable bond market, including Treasuries, government-related and corporate securities, MBS, ABS, and CMBS. The J.P. Morgan Emerging Bond Index (EBI) measures the total return performance of international government bonds issued by emerging market countries and that meet specific liquidity and structural requirements. The Bloomberg Barclays 1-3 Month U.S. Treasury Bill Index includes publicly issued U.S. Treasury Bills that have a remaining maturity of 1 to 3 months and have at least \$250 million of outstanding face value.

Ex-Post Standard Deviation: The three-year annualized ex-post standard deviation of the composite and benchmark as of December 31, 2017 are as follows: MAS Growth Composite: 9.20%; MAS blended benchmark: 9.05%. December 31, 2016 are as follows: MAS Growth Composite: 10.06%; MAS blended benchmark: 9.83%.

Gross returns are shown as supplemental information and are stated gross of all fees, except trading; net returns are reduced by all fees and transaction costs incurred. Wrap fee accounts pay a fee based on a percentage of assets under management. Wrap fee accounts make up 100% of the composite for all periods shown.

The investment management fee schedule for the wrap programs vary and will be less than or equal to two percent. Actual investment advisory fees incurred by clients may vary.

All cash reserves and equivalents are included in returns. Returns are time weighted and include reinvestment of dividends, income and gains. The MAS Growth composite was created on June 30, 2014.
